**ORDER:**

As per the minutes held with APSPEJAC & YSR Vidyut Employees Union as follows:

"The COVID health expenditure will be sanctioned irrespective of CGHS package rates for those affected as no rates exist for the same. Also the medical expenses of COVID deceased employees will also be reimbursed irrespective of CGHS package rates."

2. After careful consideration of the issue, APGENCO hereby ordered that the COVID-19 Medical Reimbursement bills shall be reimbursed to Employees/ Pensioners/ Family Pensioners and their dependents irrespective of CGHS package rates for those affected as no rates exist for the same and also the medical expenses of COVID-19 deceased employees to be reimbursed irrespective of CGHS package rates.

3. The COVID-19 Medical claims shall be accounted and reimbursed from SFMS Medical fund, if the Medical claim exceeds SFMS limits of Employees/Pensioners/Family Pensioners and to their dependents, the balance maybe reimbursed from General ceiling as per eligibility.

4. The earlier orders relating to existing Medical Scheme issued from time to time holds good.
