- d) Final allocation of State Cadre employees between APGENCO and TSGENCO, that may occur as per the A.P.Reorganisation Act.,2014, besides subject to the outcome of batch of writ petitions, No.16849/2015 and others pending before the Hon'ble High Court/ Hon'ble Supreme Court of Judicature.

Sri S.V.Ravichandra Deo, Executive Engineer (Civil) working under control of Chief Engineer/TI & Construction Stage.V/Dr NTTPS, on temporary promotion as Superintending Engineer (Civil) is transferred and posted as Superintending Engineer (Civil) under the control of Chief Engineer/O&M/SRBHES against post diverted vide ref 5th cited duly terminating alternative arrangements issued vide ref 4th cited to the post of SE/Civil/NSTPD held by Sri P.Sreerami Reddy, Executive Engineer /Civil.

5. The Chief Engineer/TI & Construction Stage.V/Dr NTTPS is requested to relieve the above Executive Engineer(Civil) by making local arrangements so as to enable him to assume charge at the place of posting ordered above, on promotion.

6. Sri S.V.Ravichandra Deo, Executive Engineer (Civil) is requested to assume charge on promotion as Superintending Engineer(Civil) at the place of posting ordered. If they fails to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, their promotion rights shall be forfeited for the current panel year and the names of such candidates shall be placed before the next DPC for the consideration in the next panel year subject to availability of vacancy in terms of G.O.O., 1st cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
