ORDER:

5. The One Jr.Personnel Officer on promotion as Personnel Officer and One Personnel Officer on transfer are posted to the places mentioned against their names in the Annexure appended to this order.
6. The Chief General Manager (Adm,IS&ERP) is requested to relieve the promote/Transferee by making local arrangements so as to enable them to join at the place of posting ordered.

7. Sri.V.Buli Raju JPO is directed to assume charge on promotion as Personnel Officer at the place of posting ordered. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dt: 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against her for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

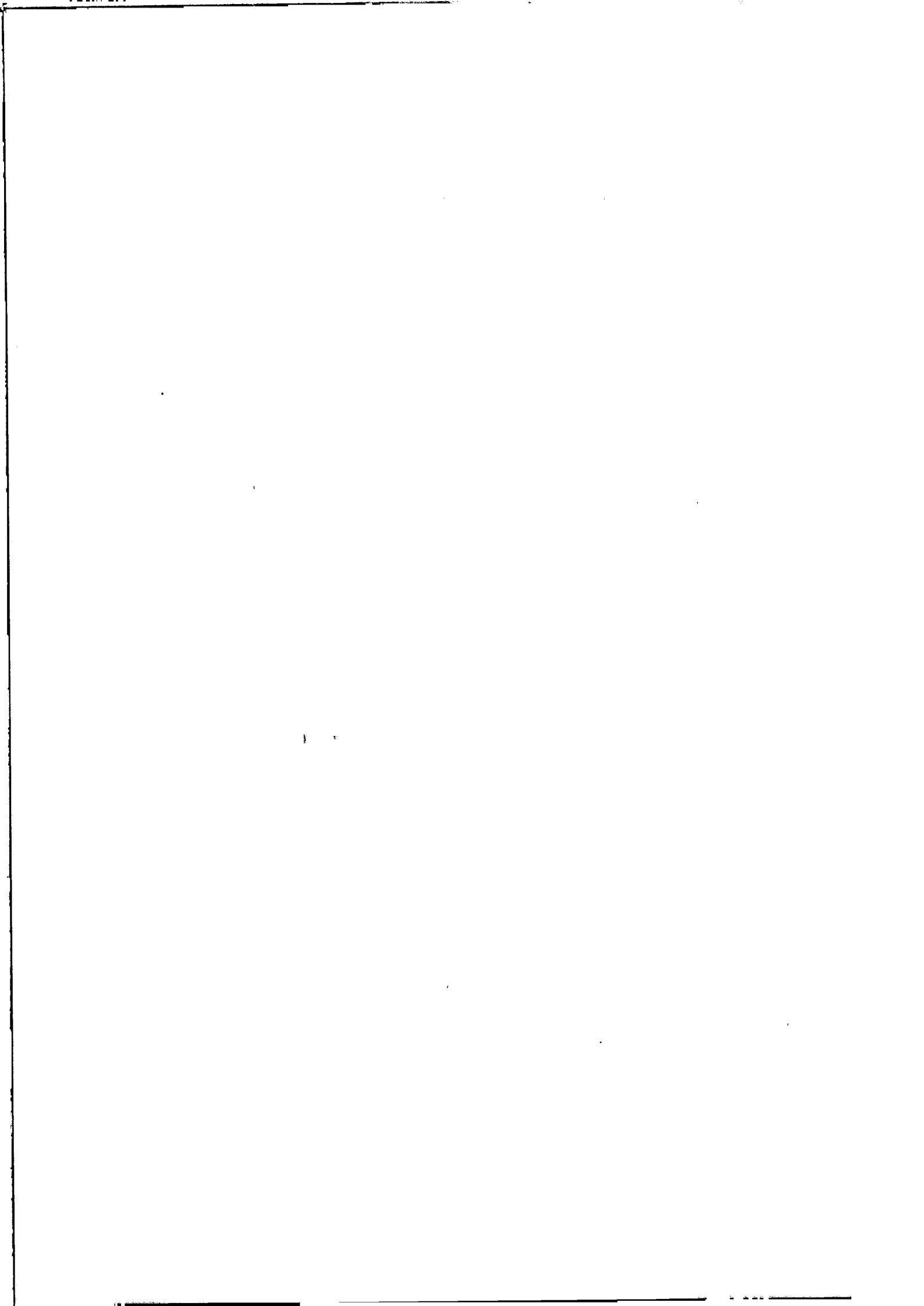
