ORDER :

The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014, besides subject to the outcome of Batch of MA No.1286/2020 & Batch CA No.11435/2018, pending before the Supreme Court of Judicature.

5. The 2 No's Accounts Officers on promotion as Senior Accounts Officers are posted to the places noted against their names in the Annexure appended to this order.

6. The concerned controlling officers are requested to relieve the promotees by making local arrangements so as to enable them to join at the places of posting ordered.

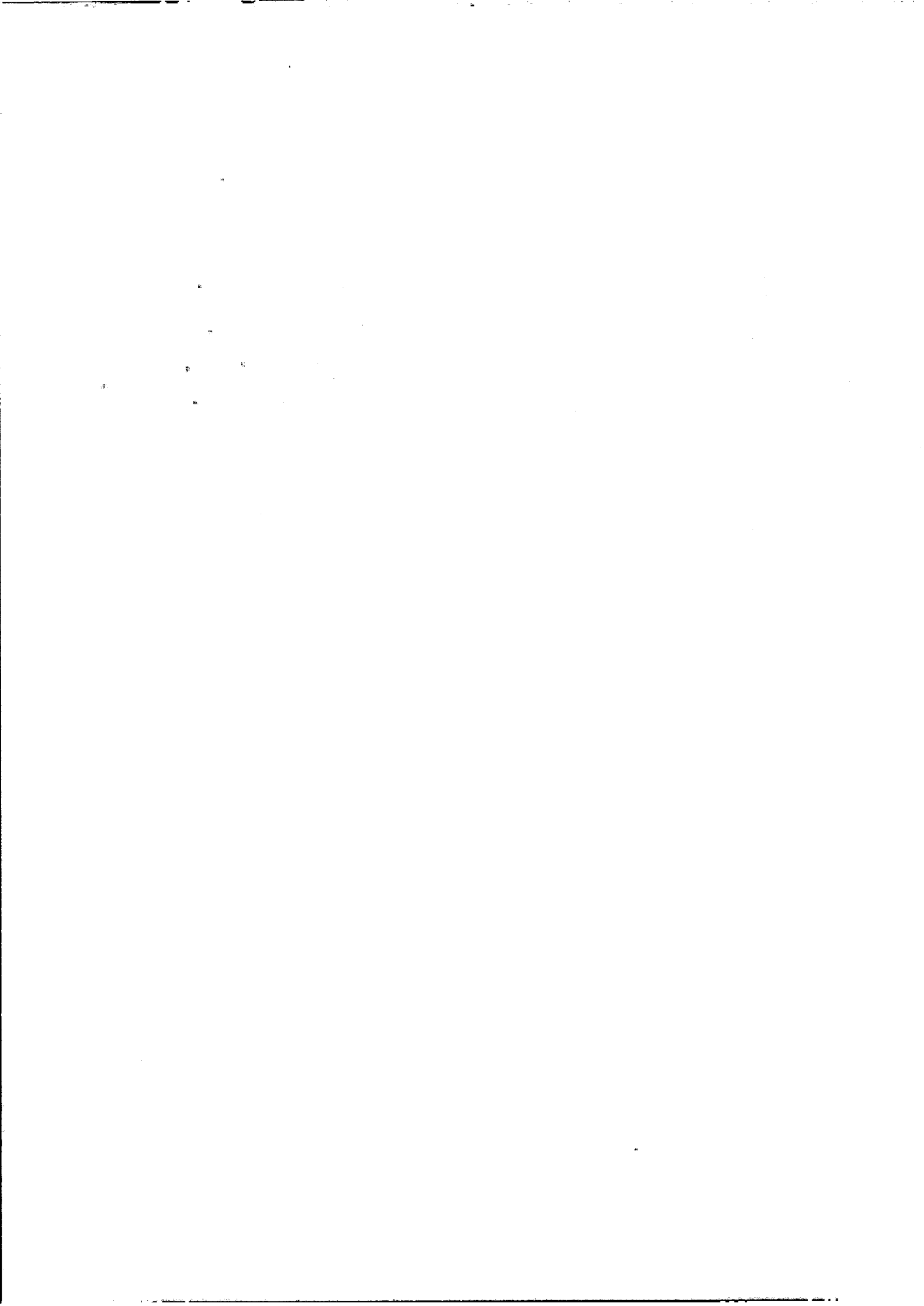
