Under Regulation 14 (a) (1) of APSEB Service Regulations Part-II as adopted read with G.O.O.No.555/JS(Per)/2008, dtd. 16.02.2009, Sri K.V. Rajeswara Reddy, Station Fire Officer/Dr.NTTPS is promoted temporarily to act as Assistant Divisional Fire Officer with effect from the date of assumption of charge.

Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
