**ORDER:**

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, Sri N.Venkata Narasaiah, Executive Chemist is promoted to act temporarily as Superintending Chemist with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotion ordered in para-1 above is liable to be reviewed subject to result of final allocation of State Cadre employees between APGENCO and TSGENCO, that may occur as per the A.P.Reorganisation Act,2014, besides subject to the outcome of batch of writ petitions, No.16849/2015 and others pending before the Hon'ble High Court Hon'ble Supreme Court of Judicature at Hyderabadnd/New Delhi.
4. Sri N.Venkata Narasaiah, Executive Chemist working under the control of CE/O&M/SDSTPS on deputation is repatriated to APGENCO and on temporary promotion as Superintending Chemist is posted under the control of Chief Engineer/O&M/SDSTPS on deputation.
5. The Chief Engineer/O&M/SDSTPS is requested to relieve the above Executive Chemist immediately by making local arrangements, to enable him to assume charge as Superintending Chemist at the place of posting ordered.
6. Sri N.Venkata Narasaiah, Executive Chemist is requested to assume charge on promotion as Superintending Chemist at the place of posting ordered. If they fails to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, their promotion rights shall be forfeited for the current panel year and the names of such candidates shall be placed before the next DPC for the consideration in the next panel year subject to availability of vacancy in terms of G.O.O., 1<sup>st</sup> cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
7. Leave salary, pension and Gratuity contributions shall be remitted by the deputation stations as per the G.O.O.No.178/JS(Per)/09, Dt: 07.08.2009.
