ABSTRACT

APGENCO -Medical - Welfare Measures - Recognition of certain Hospitals for the benefit of the employees/pensioners/dependent family members and family pensioners of APGENCO FOR availing treatment on credit basis or reimbursement basis - Orders - Issued.

ORDER:

In the references cited above, M/s AIG of Hospitals have applied for empanelment of their hospitals to render medical treatment to the APGENCO employees, pensioners, dependent family members and family pensioners on credit basis.

2) Accordingly, the Director(HR&IR) has recommended for recognition of the above Hospital as per the requirement to the APGENCO, for entering into credit tie-up with the hospital name mentioned in the para-3 below for availing of medical services by the employees/pensioners/dependent family members and family pensioners of APGENCO.

3) After careful consideration, the Managing Director/APGENCO hereby grants recognition to the **M/s. AIG Hospital, Gachibowli Village, Serilingampally, R.R. District with validity of State Govt. reorganization up to 04.03.2022** for the benefit of employees/pensioners/ dependents family members & family pensioners of APGENCO to avail medical treatment on credit basis as in-patients for chronic diseases/major operations etc., The credit cards shall be issued by the APGENCO from time to time on case to case basis only, in case the eligible persons of the APGENCO employees/ pensioners/ dependents family members & family pensioners are hospitalized for treatment of the following ailments:

- Cardiology – PTCA/Pacemakers/ EPS/RFA
- CT Surgery – CABG/AVR/MVR.
- Medical Oncology
- Surgical Oncology
- Radiation Oncology
- Haematology – Bone Marrow Transplants
- Nuclear Medicine
- Nephrology – Kidney Transplants
- Orthopedic (Knee / Hip / Shoulder / Elbow)

4) The recognition granted in para-3 above is subject to the condition that the Management of the Hospitals shall adopt the following procedure while submitting the Estimation Bill for issue of Credit Card and at the time of submitting the hospital bill for payment: -

a). The schedule of charges for treatment of APGENCO employees shall be regularized as per the schedule of approved tariff of 2014 CGHS, Hyderabad as stated in G.O.Ms.No.74, HM&FW (K1) Department dt.15-03-2005.

b). Hospitals bills for payment should follow CGHS code numbers of 2014, if any item is not available in CGHS tariff you should mention NIMS tariff 2015. The treatment under the CGHS packages bill should be produced under CGHS package by mentioning its code.

The package rate is a lumpsum cost of in-patient treatment or diagnostic procedure for which a patient has been referred by APGENCO. The package rate shall include admission charges, accommodation charges, ICU/ICCU charges, monitoring charges, operation charges, anesthesia charges, operation theatre charges, procedural charges/surgeon's fee, cost of disposable, surgical charges and cost of medicines used during hospitalization, related routine investigations, physiotherapy charges etc.,

c). The hospitals empaneled by the APGENCO have to treat i.e. Consultation, Lab tests & Radiology investigations as per CGHS-2014 tariff both for In-Patient and Out-Patient Services, to the employees, pensioners, Retired employees, dependent family members and family pensioners of APGENCO.

5) The Estimation letter without CGHS Code will not be accepted for issue of credit card and Hospital Bills for payment, over and above the CGHS package rates will be deducted from the total bill amount while scrutiny the bills for payment.

6) If any change in State Govt. regarding payments of Hospital bills/reimbursement bills the same will be followed in APGENCO.

7) The permission accorded to the hospitals are liable for cancellation and such other action as deemed fit, including de-recognition of the hospital and initiate criminal action as per law against the hospitals, whenever the APGENCO forms the opinion based on inspection or enquiry into the allegations that the said private hospital is not providing treatment to the APGENCO Employees/Pensioners and their dependents and Family pensioners etc., as stipulated above and violated the conditions mentioned therein, and indulge any irregularities in respect of excess/bogus claims, cheating the patient of APGENCO or resorting to any unlawful activities, etc., after giving fifteen (15) days' notice to the hospital and pass appropriate orders, after considering the representation, if any, offered by the said hospitals.

8) The renewal of empanelment will be considered and validity based on state Govt. approval from time to time.

9) The empaneled hospitals heads are requested to conduct Free Health Camps including Diagnostic services once in a quarter at the nearest Power Generating Station(s). The Schedule of conducting of 'Free Health Camps including Diagnostic Services' shall be communicated by the respective Hospitals to the respective station heads for smooth conducting of camps.

10) The empanelment shall be considered from the date of issue of these orders. This order issued with the concurrence Director (Finance & Commercial)/APGENCO Vide e-office, Dtd:09.08.2021. These orders are available in APGENCO website www.apgenco.gov.in
