**ORDER:**

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Smt D. Lakshmi Devi, Assistant Secretary is promoted temporarily to act as Deputy Secretary with effect from the date of assumption of charge.

2. The promotion ordered in para –1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para –1 above is subject to the result of S.L.P.Nos.2360 – 91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.

4. The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014, besides subject to the outcome of Batch of MA No.1286/2020 & Batch CA No. 11435/2018 pending before the Supreme Court Judicature.

5. After careful consideration, one vacant post of Deputy Secretary under the control of Chief Engineer/O&M/Dr.NTTPS is diverted temporarily to Corporate Office/Vidyut Soudha under the control of Chief General Manager(Adm,IS&ERP) and designated as Deputy Secretary(ERP) from the date of actual utilisation.

6. Smt D. Lakshmi Devi, Assistant Secretary on promotion as Deputy Secretary ordered above is transferred and posted as Deputy Secretary (ERP) against the post diverted in para:5 above to look after the ERP-HCM works.

7. The concerned controlling officer is requested to relieve Smt D. Lakshmi Devi, Assistant Secretary/Stationery & CRD by making local arrangements so as to enable her to join at the place of posting ordered.

8. She is directed to assume charge on promotion as Deputy Secretary at the place of posting ordered. If she fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, her promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dt: 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against her for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.


