ORDER

In the GOO 1st read above, certain comprehensive guidelines were issued for fixation and finalisation of medical bills of APGENCO. In G O O 3rd read above, APGENCO has adopted the total package rates and other ceiling procedures mentioned in G O 2nd cited and permits to take up treatment for COVID19 pandemic in hospitals. In the GOO 4th read above, COVID 19 Medical reimbursement bills from SFMS Fund to employees/pensioners/ Family pensioners and their dependents, irrespective of CGHS package rates, if the medical claim exceeds SFMS limits, the balance to be reimbursed from general ceiling as per eligibility on par with the orders issued by APTRANSCO vide T.O.O.No.(Addl. Secy.-Per.)/Ms.No.2088, dtd. 16.02.2021.

2. After careful consideration, a Committee is hereby constituted comprising of the following members to examine high value COVID 19 related bills worth more than Rs.5.00 lakhs and above to finalise amount to be allowed for reimbursement/hospital bills:

- i. Chief General Manager(Adm,IS&ERP) - Member
- ii. FA&CCA(Audit & Trust) - Member
- iii. Deputy Civil Surgeon/Vidyut Soudha - Member- Convener

3. The committee constituted above is requested to examine the high value COVID 19 related bills worth more than Rs.5.00 lakhs above and recommend the amount to be allowed for reimbursement /hospital bills.
