**ORDER:**

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, Sri K.Gopala Rao, Deputy Executive Engineer/Civil is promoted temporarily to act as Executive Engineer/Civil, with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto. It is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.

3. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of;

- a) The judgement to be delivered by the Hon'ble Supreme Court in the appeal filed against the judgement in W.P.No.2360-91/1983.
- b) The judgement to be delivered in W.P.No.8509/1988 and 10937/1989 pending before the Hon'ble High Court of A.P.
- c) The judgement to be delivered in W.P.No.3470/2008 and W.P.No.1597/2010 pending before the Hon'ble High Court of A.P. and
- d) Result of final allocation of State Cadre employees between APGENCO and TSGENCO, that may occur as per the A.P.Reorganization Act., 2014, besides subject to the outcome of batch of writ petitions, No.16849/2015 and others pending before the Hon'ble High Court / Supreme court of Judicature.

4. The 01 (One) No Deputy Executive Engineer/Civil on temporary promotion as Executive Engineer/Civil, 01 (One) No Deputy Executive Engineer/Civil on transfer are posted to the places noted against their names in the Annexure appended to this order. The promotee is requested to assume charge as Executive Engineer/Civil, at the place of posting ordered.

5. The concerned controlling officers are requested to relieve the promotee/transferee by making local arrangements, so as to enable them to assume charge at the place of posting ordered in the Annexure appended to this order.The alternative arrangements issued if any stands cancelled on assumption of charge by the concerned promotee/transferee.

6. Sri K.Gopala Rao, Deputy Executive Engineer/Civil is requested to assume charge as Executive Engineer/Civil at the place of posting ordered. If he fail to join or evade joining within stipulated period or proceed on leave from date of receipt of this order, his promotion rights shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1<sup>st</sup> cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

7. Leave salary, pension and Gratuity contributions shall be remitted by the deputation stations as per the G.O.O.No.178/JS(Per)/09, Dt: 07.08.2009.
