ORDER :

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Sri M.Nagendra Kumar, Deputy General Manager/(HR)/VS/VJA is promoted temporarily to act as General Manager (HR) with effect from the date of assumption of charge.

2. The promotion ordered in para –1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotion ordered in para –1 above is subject to the result of S.L.P.Nos.2360 –91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.
4. The promotion ordered above is subject to the result/review of final allocation of State cadre employees between APGENCO & TSGENCO, that may occur as per the AP Re-organization Act, 2014, besides subject to the outcome of Batch of MA No.1286/2020 and Batch CA No.11435/2018 and before the Supreme Court Judicature.
5. Sri. M.Nagendra Kumar, Deputy General Manager (HR)/VS/VJA on temporary promotion as General Manager (HR) ordered in para-1 above, is transferred and posted under the control of Chief General Manager (Adm, IS&ERP) against the post restoration orders issued in the reference 3rd cited.

If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dt: 02.08.2008. Necessary departmental disciplinary action is deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
