**ORDER:**

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Two (02) Nos. of the Junior Personnel Officers mentioned in the Annexure appended to this order are promoted temporarily to act as Personnel Officers with effect from the date of assumption of charge.

2. The promotion ordered in para–1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is subject to the result of S.L.P.Nos.2360-91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P.No.1173/91 pending in the Honourable High Court of Andhra Pradesh.

4. The Two (02) Nos. Junior Personnel Officers on temporary promotion as Personnel Officers ordered at para–1 above are posted to the places noted against their names in the Annexure appended to this order, duly terminating the Incharge arrangements ordered vide ref. 3<sup>rd</sup> cited above.

5. The Concerned Controlling Officers are requested to relieve the promotees so as to enable them to join at the place of posting ordered.

6. The promotees are requested to assume charge on promotion as Personnel Officer at the place of posting ordered. If they fail to join or evade joining within the 15 Days from the date of receipt of this order or proceeded on leave, their promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No.231/JS(Per)/2008, dt.02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
