ORDER:

In the G.O.O. 1st read above, orders have been issued enhancing the reimbursement of the Tuition Fee for the Children of Class IV Employees and Non-Gazetted Officers from Rs.400/- to Rs.1,000/- per annum uniformly for all Classes from L.K.G. to Intermediate/12th Class subject to the conditions regarding the submission of cash receipt, certificate, etc., as per the existing Rules & Regulations from the Academic Year 2010-11.

2) In the reference 2nd read above, the Government of Andhra Pradesh has enhanced the reimbursement of Tuition Fee from Rs. 1,000/- to Rs. 2,500/- per annum, per child, subject to a maximum of two children, in respect of Non-Gazetted Officers and Last Grade Employees studying in all the Classes from L.K.G. to Intermediate/12th Class, subject to the other usual conditions regarding submission of receipts, certificate, etc., as per the existing Rules and Regulations.

3) The APGENCO after careful consideration hereby adopts the orders of the Government issued in the reference 2nd cited, and accords approval for enhancement of reimbursement of Tuition Fee from Rs.1,000/- to Rs.2,500/- per annum per child, subject to a maximum of Two (02) Children in respect of all the Non-Gazetted Officers and Last Grade Employees, studying in all Classes from L.K.G. to Intermediate/12th Class subject to the other usual conditions regarding the submission of cash receipt, certificate, etc., as per the existing Rules and Regulations.
