APGENCO – Medical – Enhancement of Expenses towards Eye Treatments – Orders - Issued.

G.O.O.No.510/JS(P)/2018, dt.27.03.2019.

ORDER:

In the clause (6) of G.O.O cited, Eye treatment to the Employees/Pensioners & their dependents and family pensioners, shall be sanctioned to a maximum of Rs. 20,000/- or amount claimed whichever is less for 3 times in life time irrespective of category/cadre as per the conditions mentioned therein. The expenditure towards the eye treatment is accounted under general ceiling limits.

- 2) The Pensioner's association has requested to enhance the ceiling limits as the cost of treatment for Eye ailments has increased enormously.
- 3) After careful consideration and keeping in view the enhanced cost of expenditure for Eye treatment, it has been decided to enhance the maximum ceiling rates for Eye treatment for each spell from Rs. 20,000/- to Rs. 40,000/- and accounted under SFMS irrespective of Category/Cadre of Employees/Pensioners & their dependents and family pensioners. The other terms and conditions mentioned in GOO cited remains unaltered.
