After careful examination, the APGENCO is hereby issues following Amendment to Regulation 12 of APSEB General Provident Fund Regulations as adopted.

AMENDMENT

Add the following as proviso below to the existing Regulation 12 (1) (b) (vi) of APSEB GPF Regulations.

- “vii) Provided that the sum of the monthly subscriptions in terms of (b) (i) to (vi)above,during a financial year together with the amount of arrear subscriptions deposited in that financial year shall not exceed the threshold limit of Rs.5.0 lakhs.”
2. The above Amendment is applicable from the financial year 2023-24 onwards.
