**ORDER:**

After careful consideration, the APGENCO in exercise of the powers conferred to in Regulation 41 of APSEB Service Regulations Part-II as adopted by APGENCO and Rule-7 of the AP Electricity Reforms (Transfer Scheme) Rules, 1999, hereby issues the following Amendments to Annexure-I referred to in Regulation-9 of B.P.Ms.No.419, dt.18.06.1975 of APSEB Security Subordinate Service Ad-hoc Regulations.

**AMENDMENTS**

- (1) For the existing cadres in Annexure-I referred to in Regulation 9 namely:

Class-IV

- Category-1 - Naik Security Guards  
Category-2 - Lance Naik Security Guards  
Category-3 - APGENCO Constable

Substitute the following:

Class-IV

APGENCO Constable.

- (2) For the existing provision against APGENCO Head Constable namely:

(2) by Promotion from the ranks of Naiks”

Substitute the following:

“(2) By promotion from the category of APGENCO Constable.”

- (3) For the existing provision below Class-IV namely :

- (4) For the existing provision "Method of Recruitment" under the head "APGENCO Head Constable" namely:

"By Promotion from the ranks of Security Guards. The Head Security Guards will be on probation for a period of ONE YEAR within a continuous period of TWO YEARS. "

Substitute the following:

"By promotion from the category of **APGENCO Constable**

1. Should be an approved probationer in the category of APGENCO Constable.
2. Shall render Service as APGENCO Constable for not less than;
  - a. 06 Years (with Intermediate, ITI (10<sup>th</sup> Class + 2 Years ITI) or equivalent qualification).
  - b. 08 Years (without Intermediate, ITI or equivalent qualification).
3. Must secure 60% & above in the Written Test, 35% & above in Drill Test and found satisfactory in the Oral Examination.
4. The Period of EOL, Suspension period treated as such, shall not be considered for Service.

**Note:** Written Test will be conducted in Law, and Industrial Security, each paper carrying 50 marks the written test will consists of the following:

- a. Objective Type - 60 Marks
- b. Descriptive Type - 30 Marks
- c. Fill in the Blanks - 10 Marks "

- (5) For the existing provision under "Qualification for direct recruitment" under the head "Class-IV (APGENCO Constable)" namely:

"(3) He must have passed Inter Science or I.T.I. Qualification – vide .BP.Ms. No. 407 dt.07.04.1979.

**Note:** Ex-Army personnel possessing requisite qualification are eligible for appointment provided they have not been dismissed or dis-charged from services as a measure of punishment. The Board may at its discretion relax the qualification and age limit in respect of such candidates provided they are otherwise found fit.

There will be no Direct Recruitment for Class IV Categories 1 & 2."

Substitute the following:

" (3) He must have passed Inter or I.T.I (10<sup>th</sup> class + 2 Years ITI) or equivalent qualification.

**Note:**

Ex-Army personnel possessing requisite qualification are eligible for appointment provided they have not been dismissed or discharged from services as a measure of punishment. The Board may at its discretion relax the qualification and age limit in respect of such candidates provided they are otherwise found fit."

- (6) **Delete:** " Class-IV – Category-2; Category-3 and all the provisions therein under the Head "APGENCO Head Constable".
