ORDER:

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Sri M. Murali Krishna, Senior Accounts Officer is promoted temporarily to act as General Manager with effect from the date of assumption of charge.

2. The promotion ordered in para–1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotion ordered in para–1 above is subject to the result of S.L.P.Nos.2360 – 91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.

Murali Krishna, Senior Accounts Officer, O/o CE/O&M/SDSTPS on deputation is repatriated to APGENCO, and on temporary promotion as General Manager ordered above, is posted as General Manager (Audit) to the control of Chief General Manager (Audit & Trust), APGENCO in the existing vacancy duly terminating the look after arrangements made, if any.
5. The concerned controlling officer is requested to relieve Sri M. Murali Krishna, Senior Accounts Officer by making local arrangements so as to enable him to join at the place of posting ordered.

Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
