**ORDER:**

Under Reg.14(a) (1) of APSEB Service Regulations Part-II, as adopted, One (01) No. Deputy Executive Engineer/Mechl is promoted temporarily to act as Executive Engineer/Mechl, with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto. Sri B.S.Nageswara Rao, Deputy Executive Engineer/Mechl working under the control of Chief Engineer/O&M/SRBHES on temporary promotion as Executive Engineer/Mechanical, is posted to the control of Chief Engineer/O&M/SRBHES against the post diverted vide reference 3<sup>rd</sup> cited. He is requested to assume charge on promotion as Executive Engineer/Mechl at the place of posting ordered.

Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
