In the meeting conducted on 09-08-2023 at A.P. Secretariat in the presence of Hon'ble Minister for Energy, Hon'ble Minister for Education, Special Chief Secretary to Energy Department and Special Chief Secretary to Finance, GoAP., with the representatives of Unions & Associations, it is assured that the present existing medical policy will be enhanced for medical reimbursement to the Employees/Pensioners/Family Pensioners and their dependents of APGENCO.

2. Accordingly, after careful consideration, APGENCO hereby enhances the ceiling limits of the existing Medical policy as detailed hereunder:

Sl No	Category	Existing Ceiling Amount	Enhanced Ceiling Amount
1	General	Rs.5.00 Lakhs for Life time	Rs.10.00 Lakhs for Life time
2	Major	Rs.12.00 Lakhs for Major ailments/Surgeries/ Treatments i.e., CABG, Double Valve Replacement, Kidney Transplantation, Cancer, Neuro-surgery, Aortic Valve Replacement, PTCA STENT be restricted to three spells for each of these diseases maximum ceiling limit of Rs.4.00 Lakhs for each spell.	Rs.15.00 Lakhs for Major ailments /Surgeries/ Treatments i.e., CABG, Double Valve Replacement, Kidney Transplantation, Cancer, Neuro-surgery, Aortic Valve Replacement, PTCA STENT be restricted to three (3) spells for each of these diseases maximum ceiling limit of Rs.5.00 Lakhs.

3. Further, the Employees/Pensioners/Retired Employees & their dependent family members and Family Pensioners of APGENCO those who have already availed the ceiling limit prior to this order, shall be allowed to avail the remaining amount from the enhanced ceiling amount.
4. The enhanced General/Major Ceiling limits shall come into force with effect from the date of issue of these orders.
5. The other orders which were already in force remains unaltered.
