**ORDER:**

Under Regulation 14 (a) (1) of APSEB Service Regulations Part-II as adopted, the following ONE (01) Leading Fireman and ONE (01) Driver Operator are promoted temporarily to act as Station Fire Officer with effect from the date of their respective assumption of charge:

- ii) P. Ravi Sankar, Driver Operator

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The Leading Fireman and Driver Operator, on temporary promotion as Station Fire Officer ordered at para-1 above are posted to the places noted against their names in the Annexure appended to this order.

4. The Concerned Controlling Officer is requested to relieve the promotees' so as to enable them to join at the place of posting ordered.

5. The promotees' are requested to assume charge on promotion as Station Fire Officer at the place of posting ordered. If they fail to join or evade joining within the 15 Days from the date of receipt of this order or proceeded on leave, their promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in the ref. 1<sup>st</sup> cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.


