ORDER:

The ANDHRA PRADESH POWER GENERATION CORPORATION LIMITED hereby accords sanction for the Rates of Dearness Allowance (DA) to all the Employees of APGENCO in the Revised Pay Scales, 2022 and Dearness Relief (DR) to the Pensioners/Family Pensioners with effect from 01-07-2022 as indicated below:

Rate of Dearness Allowance / Dearness Relief from 01.01.2022	Rate of Revised Dearness Allowance / Dearness Relief from 01.07.2022
24.99%	2.92%

2. The Dearness Allowance to all the Employees of APGENCO who are under Revised Pay Scales, 2018 as indicated below:

Rate of Dearness Allowance From 01.01.2022	Rate of Revised Dearness Allowance From 01.07.2022
24.99%	28.64%

3. The Dearness Allowance shall be paid on Basic Pay only (excluding Personal Pay).

4. The Dearness Relief to the Pensioners/Family Pensioners shall be paid as per the increased rates.

5. The Dearness Allowance Arrears as per the increased rates shall be paid in 12 equal installments in cash, and for the month of September, 2023 salary payable in October, 2023 onwards.
6. The Dearness Relief arrears to the Pensioners/Family Pensioners as per the increased rates shall be paid in 12 equal monthly installments in cash, and for the month of September, 2023 Pension/Family Pension payable in October, 2023 onwards.
7. The Dearness Allowance/Dearness Relief so calculated shall be rounded off to the next rupee.
