ORDER:

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, 01 (One) No. Executive Engineer/Elecl is promoted to act temporarily as Superintending Engineer/Elecl with effect from the date of assumption of charge.

 - b) W.P.No.19836/2000, W.P.No.3470/2008 and 14264/2009 pending before the Hon'ble High Court of A.P,
5. Sri P.Rama Mohana Murthy, Executive Engineer/Elecl working under the control of Chief Engineer/O&M/SDSTPS (On deputation), is repatriated to APGENCO and on temporary promotion as Superintending Engineer/Elecl is posted as Superintending Engineer/E&M Construction & CHP/Stage-IV/Dr.M.V.R.RTPP against the vacancy caused due to transfer of Sri N.Venkata Rao (Emp Id:1061477), SE/Elecl/Dr.M.V.R.RTPP vide ref 3rd cited. The promotee is requested to assume charge as Superintending Engineer/Elecl, at the place of posting ordered.
6. The concerned controlling officer is requested to relieve the promotee by making local arrangements, so as to enable them to assume charge at the place of posting ordered. The alternative arrangements issued if any stand cancelled on assumption of charge by the concerned promotee.

7. Sri P.Rama Mohana Murthy, Executive Engineer/Elecl is requested to assume charge on promotion as Superintending Engineers/Elecl at the place of posting ordered. If he fail to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel year and the names of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1st cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

8. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble High Court against the Writ Petitions pending if any.
