ORDER:

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Sri M. Ramesh, Senior Accounts Officer is promoted temporarily to act as General Manager (Finance) with effect from the date of assumption of charge.

2. The promotion ordered in para–1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para–1 above is subject to the result of S.L.P.Nos.2360–91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P. No.1173/91 pending in the Honourable High Court of Andhra Pradesh.

4. Sri M. Ramesh, Senior Accounts Officer, working under the control of Chief Financial Officer/APPDCL on deputation is repatriated to APGENCO, and on temporary promotion as General Manager (Finance) ordered above is posted General Manager (Finance)/Dr.NTTPS vice Sri A.S. 5. On relief, Sri. A.S. Balaji, General Manager (Finance) is transferred and posted as General Manager (Finance)/Dr. M.V.R. RTPP.

7. Sri M. Ramesh, Senior Accounts Officer is requested to assume charge on promotion as General Manager (Finance) at the place of posting ordered after obtaining proper relief from the present post. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No.231/JS(Per)/2008, dt.02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.

8. Leave Salary, Pension and Gratuity Contributions shall be remitted by the deputation stations as per the G.O.O.No.178/JS(Per)/2009, dt.07.08.2009.
