**ORDER:**

5. On relief, Sri G.V.V. Satyanarayana, Chief General Manager is transferred and posted as Chief General Manager (Resources & Accounts) in the existing vacancy duly terminating the Additional Charge arrangements made vide ref. 3<sup>rd</sup> cited.

Ramana Rao, General Manager is requested to assume charge on promotion as Chief General Manager (Audit & Trust) at the place of posting ordered, after obtaining proper relief from the present post of General Manager. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No.231/JS(Per)/2008, dt.02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
