**ORDER:**

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, 13 (Thirteen) No Assistant Executive Engineers/Elecl & 03 (Three) No Assistant Engineers/Elecl mentioned in the annexure appended to this order are promoted temporarily to act as Deputy Executive Engineers/Elecl with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.

4. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of;

- a) W.P.No.2360-91/1983 filed by Retired Officers of the Board and pending in the Supreme Court and W.P.Nos.77074/93, 17126/93, 5221/93, 10199/92 pending in the High Court of A.P. and
- b) W.P.No.19836/2000, W.P.No.3470/2008 and 14264/2009 pending before the Hon'ble High Court of A.P.

5. The 13 (Thirteen) No Assistant Executive Engineers/Elecl & 03 (Three) No Assistant Engineer/Elecl on temporary promotion as Deputy Executive Engineers/Elecl; Transfer of 13 (Thirteen) No. Deputy Executive Engineers(Elecl/Telecom); Transfer of 03 No. AEEs/AE(Elecl) & Retention of 01 (One) No. AEE/Elecl are posted to the places noted against their names in the Annexure appended to this order.The promotees/Transferees are requested to assume charge as Deputy Executive Engineers/Assistant Executive Engineers/Assistant Engineers, at the place of posting ordered.

6. The concerned controlling officers are requested to relieve the promotees/transferees duly making local arrangements, so as to enable them to assume charge as Deputy Executive Engineers/Assistant Executive Engineers/Assistant Engineers on promotion/transfer/retention at the place of posting ordered above. The alternative arrangements issued if any stands cancelled on assumption of charge by the concerned promotee/transferees.

7. The promotees are requested to assume charge on promotion as Deputy Executive Engineers/Elect at the place of posting ordered. If they fail to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, their promotion rights shall be forfeited for the current panel year and the names of such candidates shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1<sup>st</sup> cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

8. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble High Court against the Writ Petitions pending if any.

9. Leave Salary, Pension and Gratuity contributions shall be remitted by the deputation stations as per the G.O.O.No.178/JS (Per)/09, Dt: 07.08.2009.
