Order:

In the reference 2nd cited, the Chief Engineer (HPC & Hydel Projects)/APGENCO, V.S., has requested to arrange the payment of Rs.5,00,000/- each to the 3 nos Arbitrators of the Arbitration Tribunal as mentioned in the Procedural order No.19.

2) The APGENCO has nominated Hon'ble Justice B.Seshasayana Reddy, Judge(Rtd.), High Court of A.P as its nominee Arbitrator and M/s.NECL has nominated Sri.M.K.Rahman, Engineer in Chief(Rtd.), I&CAD Department, Govt. of A.P as its nominee Arbitrator. The both the nominee Arbitrator collectively chosen Hon'ble Justice G.Rohini, Former Chief Justice of Delhi High Court as Presiding Arbitrator vide letter dt.04.10.2021.

3) In the ref.1st cited, the Arbitral Tribunal has passed the procedural Order No.19, wherein at Point No.6 i.e., "The Parties had earlier remitted Rs.5,00,000/- each to each one of the Arbitrators towards initial payment of the fees of this Arbitral Tribunal pursuant to the order dated 24.10.2021. The parties shall now make a further payment of Rs.5,00,000/- each, to each one of the Arbitrators towards the fees of the Arbitral Tribunal before the next date of hearing (21.04.2023). The particulars of Bank Accounts of the Arbitrators were furnished in the procedural Order No.1, dated 24.10.2021 as corrected in the Corrigendum dated 27.10.2021."

4) After careful consideration, and in exercise of delegation of powers ordered in G.O.O.No.129/JS(Per)/2016, dated 15.07.2016, sanction is hereby accorded for total an amount of **Rs.15,00,000/-** (Rupees Fifteen Lakhs only) towards the fees of the Arbitral Tribunal of 3 Nos Arbitrators i.e., i) Rs.5,00,000/- to Sri. B.Seshasayana Reddy, ii) Rs.5,00,000/- to Sri. M.K.Rahman and iii) Rs.5,00,000/- to Smt.G.Rohini. The applicable GST shall be paid by APGENCO on the said payments.
