Rajasekhar, Assistant Accounts Officer, RTPP is permitted to retire from service voluntarily w.e.f. 30.06.2023 A. N at his own request.

3. The dues if any outstanding, with interest thereon shall be recovered in one lump-sum from his terminal benefits.

Rajasekhar, Assistant Accounts Officer, RTPP is directed to submit an undertaking that he would not seek such employment and set up or engage in a business or a commercial undertaking as a principal, within a period of two years from the date of voluntary retirement, without the prior permission of the APGENCO.
