**ORDER:**

4. Sri Sk. Sana Vulla, Junior Accounts Officer on temporary promotion as Assistant Accounts Officer ordered at para-1 above, is transferred and posted to the control of the Chief Engineer/O&M/SRBHES.

5. The Concerned Controlling Officer is requested to relieve the promotee so as to enable him to join at the place of posting ordered.

6. Sri Sk. Sana Vulla, Junior Accounts Officer is requested to assume charge on promotion as Assistant Accounts Officer at the place of posting ordered.
