In the references 1<sup>st</sup> and 2<sup>nd</sup> read above, the Government of Andhra Pradesh issued an amendment to Rule-28 of A.P. Subordinate Service Rules, 1996 stating that the employees who relinquished his/her right for promotion shall be considered for promotion in future vacancies, in the next panel year, if otherwise eligible.

2) In exercise of the powers referred to in Regulation 41 of APSEB Service Regulations Part-II, as adopted by APGENCO, Regulation 4 of Service Regulation Part-I and Rule 7 of Andhra Pradesh Electricity Reforms (Transfer Scheme) Rules, 1999, Andhra Pradesh Power Generation Corporation Limited hereby issues the following amendment to APSEB Service Regulations Part-II as adopted by APGENCO with immediate effect.

**AMENDMENT**

Substitute the following for the existing Regulation-40 of APSEB Service Regulations Part-II as adopted.

Regulation-40 “Relinquishment of rights by members: Any person may, in writing, relinquish any right or privilege to which he/she may be entitled under these regulations if, in the opinion of the appointing authority, such relinquishment is not opposed to the interest of the administration; and nothing contained in these regulations shall be deemed to require the recognition of any right to or privilege to the extent to which it has been so relinquished. However, any person who relinquished his/her right for promotion earlier shall be considered for promotion in future vacancy, in the next panel year, if otherwise eligible. The persons who relinquished rights for promotion shall not be eligible for appointment to SPP-I under Automatic Advancement Scheme.”
