The ANDHRA PRADESH POWER GENERATION CORPORATION LIMITED hereby accords sanction for the Rates of Dearness Allowance (DA) to all the Employees of APGENCO in the Revised Pay Scales, 2022 and Dearness Relief (DR) to the Pensioners / Family Pensioners with effect from 01-01-2023 and 01-07-2023 shall be as indicated below:

01.07.2023	01.07.2023	5.90%	2.88%	8.78%

2. The Dearness Allowance to all the Employees of APGENCO who are under Revised Pay Scales, 2018, whose increment date falls on or before 31.03.2023 as per the options exercised shall be as indicated below:

Rate of Dearness Allowance / Relief from 01.07.2022	Rate of Revised Dearness Allowance / Relief from 01.01.2023
28.64%	32.36%

3. The Dearness Allowance shall be paid on Basic Pay only (excluding Personal Pay) as per the increased rates as mentioned above.

4. The Dearness Relief to the Pensioners/Family Pensioners shall be paid as per the increased rates.

5. The Dearness Allowance/Relief now sanctioned shall be paid in cash along with the salary/pension/family pension for the month of March, 2024 payable in April, 2024. The arrears on account of payment of Dearness Allowance/Relief as per the increased rates shall be paid in 12 equal installments along with the salary/pension/family pension for the month of April, 2024 payable in May, 2024.
6. The Dearness Allowance so calculated shall be rounded off to the nearest rupee. The Dearness Relief so calculated shall be rounded off to the next higher rupee.
