APGENCO – Regulations – Constitution of Medical Board for certifying of Special Disability Leave to the employees of APGENCO who met with accidents while on duty – Orders – Issued.

ORDER:

In terms of Regulation 22 (3) of APSEB Leave Regulations, as adopted by APGENCO, Special Disability Leave to an employee of Class-I & II, who is disabled by injury, intentionally inflicted, or caused in or in consequence of the due performance of his official duties or in consequence of his official position, shall be granted on production of certificate from the Medical Board.

2. The Medical Board in APGENCO, before bifurcation into APGENCO & TSGENCO as per AP Re-organization Act, 2014, was constituted with the following members:

3. Consequent to shifting of APGENCO Head Quarters from Hyderabad to Vijayawada, the issues/subjects, hitherto being referred to APGENCO Medical Board are being referred to the Medical Boards of the respective Government General Hospitals.

7. The concerned Station Head to forward the request of Class-I & Class-II employee(s) who intends to apply Special Disability Leave to the Member Convener of the Medical Board with his/her recommendations along with accident report of Factory Manager/Safety Officer.
