ORDER:

As per the orders issued vide G.O.O. 5th cited, the rates prescribed in the CGHS package by Government of India were adopted for the purpose of reimbursement of medical expenditure incurred by the employees/pensioners and their dependents and family pensioners as in-patient when the treatment taken either in private hospitals empanelled by APGENCO or recognized by Director of Medical Education (DME) of Government of Andhra Pradesh. It has also been ordered therein if any rates not covered in the said procedure the scrutiny authority is empowered to take decision based on the nature of disease/necessity of treatment/medicines duly comparing with the tariff of NIMS or to actuals of receipt whichever is less. The claims pertaining to Medical credit cards issued shall be subject to ceilings as per the CGHS-2014/NIMS-2015 tariff.

2. The CGHS/NIMS have released updated tariffs viz CGHS 2022 and NIMS 2017. Further, the CGHS has issued circulars vide references 3rd & 6th cited revising the tariffs/ceiling rates for Knee/HIP-implants, Consultation fee, Room Rent and ICU charges.

3. After careful consideration, the APGENCO hereby ordered that the CGHS/NIMS tariffs and Circulars issued from time to time shall be made applicable to the corresponding treatment period for reimbursement of medical bills and for issue of credit cards for the treatment of employees/ pensioners and their dependents and family pensioners.
4. The other terms and conditions ordered vide ref 5th cited remains unaltered.
5. These orders shall be applicable for the admissions on or after 26.07.2023.
6. These orders issued with the concurrence of the Director (Finance & Commercial) vide e-office dt.20.7.2023.
