**ORDER:-**

In the references 5<sup>th</sup> – 18<sup>th</sup> cited above, certain Private Hospitals have requested the APGENCO for empanelment of their hospitals with the

APGENCO to extend medical facilities to the Employees/Pensioners and their dependent family members & family pensioners on credit letter basis.

2) After careful examination, the APGENCO, hereby grants recognition to the following 14 Nos. Hospitals to the benefit of Employees/Pensioners and their dependent family members & family pensioners of APGENCO to avail medical treatment on credit basis as in-patients for General/Chronic Diseases/Major operations etc. The credit letter shall be issued by APGENCO from time to time on case to case basis only, to the eligible personal of APGENCO Employees/Pensioners and their dependent family members & Family Pensioners are hospitalized for treatment as In-Patient. The validity of each hospital is mentioned against the hospital name.

3) APGENCO issuing credit letters to the hospitals having valid DME certification and also allowing reimbursement of medical expenses claims as per the tariff rates specified in CGHS/NIMS tariff duly permitting the DME certification hospitals who have requesting for empanelment for offering treatment from time to time.

4) The recognition granted in para-2 above is subject to the condition that the Management of the Hospitals shall adopt the following procedure while submitting the Estimation Bill for issue of Credit letter and at the time of submitting the hospital bill for payment:-

a) The schedule of charges for treatment of APGENCO employees shall be regularized as per the schedule of approved charges of CGHS, Hyderabad as stated in G.O.Ms.No.74, HM&FW (K1) Department dt.15-03-2005 and G.O.O 3<sup>rd</sup> cited.

b) The Hospitals bills for payment should follow CGHS code numbers of 2022, If any item is not available in CGHS tariff should mention NIMS latest tariff 2017. The treatment under the CGHS packages bill shall be produced under CGHS package by mentioning its code. The package rate is a lump-sum cost of in-patient treatment or diagnostic procedure for which a patient has been referred by APGENCO. The package rate shall include admission charges, accommodation charges, ICU/ICCU charges, monitoring charges, operation charges, anesthesia charges, operation theatre charges, procedural charges/surgeon's fee, cost of disposable, surgical charges, cost of medicines used during hospitalization, related investigations, physiotherapy charges etc.,.

- c) The rates for Dental and Eye treatment shall be charged as given in Annexure-I and II of G.O.Ms.No.74, HM & FW(K1) Department Dt. 15.03.2005. The credit card will not be issued for Dental and Eye treatment.
- d) The hospitals empanelled by the APGENCO have to treat i.e. Consultation, Lab tests & Radiology investigations as per CGHS-2022 tariff both for In-Patient and Out-Patient Services, to the Employees, Pensioners and their dependent family members & Service Pensioners of APGENCO.
- 5) The estimation letter without CGHS Code will not be accepted for issue of credit letter and Hospital Bills for payment, over and above the CGHS package rates will be deducted from the total bill amount while scrutiny the bills for payment.
- 6) If any change in State Govt. regarding payments of Hospital bills/ reimbursement bills the same will be followed by APGENCO.
- 7) The permission accorded to the hospital is liable for cancellation and such other action as deemed fit, including de-recognition of the hospital and initiate criminal action as per law against the hospital, whenever the APGENCO forms the opinion based on inspection or enquiry into the allegations that the said private hospital is not providing treatment to the APGENCO Employees/Pensioners and their dependents & Family pensioners as stipulated above and violated the conditions mentioned therein, and indulge any irregularities in respect of excess/bogus claims, cheating the patient of APGENCO or resorting to any unlawful activities, etc., after giving fifteen (15) day's notice to the hospital and pass appropriate orders, after considering the representation, if any, offered by the said hospital.

8) The empanelled hospital heads are requested to conduct Free Health Camps including Diagnostic services once in a quarter at the nearest Power Generating Station(s). The Schedule of conducting of 'Free Health Camps including Diagnostic Services' shall be communicated by the respective Hospitals to the respective Station Heads for smooth conducting of camps.

9) The empanelment shall be considered from the date of issue of the orders. The hospitals shall apply for renewal well in advance from the date of its expiry.
