ORDER:

In the G.O.O cited, guidelines and ceiling limits for the BSNL Cell One CUG, Residential Landline and other connections for the usage of APGENCO Officials of categories I to V, have been issued.

2. Certain officers are requested to allow them to migrate from BSNL CUG to other cellular net work connections for official utilization due to poor signal strength of BSNL network at their respective locations.
3. After careful consideration, it is hereby ordered that the officers covered under Category -II, III & IV (EE /Equivalent and above cadres) and presently covered under BSNL CUG facility are now permitted to opt for mobile number portability to any other cellular net work for official utilization at their request. An amount of Rs.220/- + GST as applicable per month shall be reimbursed.
4. The concerned Station Head/ Chief General Manager (Adm,IS&ERP) are authorized to accord approval of requests for mobile number portability.
5. These orders shall come in to force with effect from 01.06.2024.
