In exercise of the powers conferred to in Regulation–41 of APSEB Service Regulations Part-II, as adopted by APGENCO, and Rule–7 of the A.P. Electricity Reforms (Transfer Scheme) Rules, 1999, APGENCO hereby issues the following amendment to APSEB Service Regulations Part-III, as adopted by APGENCO:

AMENDMENT

Under **column (3)** against Category (4) “Junior Assistant” in **column (1)** and “By Direct Recruitment” in **column (2)** under main heading “A.P.S.E. BOARD ACCOUNTS SERVICE” and sub-heading “**Class–III**” of Annexure-III to Regulation–14 of APSEB Service Regulations Part–III:

Must have passed Diploma in Computer Applications from any of the recognized University / recognized Polytechnic Institution approved by the Director of Technical Education, Govt., of A.P. / Institutions owned by State or Central Government and Institutions recognized by Computer Society of India (CSI).</p> <p>Provided that in respect of initial appointment to dependents of deceased employees, the qualification for pass in D.C.A. as mentioned above shall be relaxed. They should, however, acquire the said qualification within two years from the date of their appointment.</p>	<p>ii. Must pass the Computer Proficiency Test (CPT) conducted by APPSC or the State Board of Technical Education and Training, Andhra Pradesh or any State or Central University recognized by the University Grants Commission (UGC) or State Government, as notified vide G.O.Ms.No.26, General Administration (Ser.B), Department, dt.24.02.2023.</p> <p>Provided that in respect of initial appointment to dependents of deceased employees, the qualification for pass in C.P.T. as mentioned above shall be relaxed. They should, however, acquire the said qualification within two years from the date of their appointment.</p>
