ORDER:

Mohana Rao, Senior Accounts Officer, working under the control of Chief General Manager (R&A) on temporary promotion as General Manager (Finance) ordered above is transferred and posted on deputation as Chief Financial Officer/APPDCL on usual terms and conditions of deputation, duly terminating the additional charge arrangements made vide reference 3rd cited.

5. The concerned controlling officer is requested to relieve Sri M. Mohana Rao, Senior Accounts Officer by making local arrangements so as to enable them to join at the place of posting ordered.

6. Sri M. Mohana Rao, Senior Accounts Officer is requested to assume charge on promotion as General Manager (Finance) at the place of posting ordered after obtaining proper relief from the present post. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No.231/JS(Per.)/2008, dt.02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
