ORDER:

Under Reg.14(a) (1) of APSEB Service Regulations Part-II, as adopted, One (01) No. Deputy Executive Engineer/Mechl is promoted temporarily to act as Executive Engineer/Mechl, with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto. The promotion ordered in para-1 above is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.

3. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of;
 - a) W.P.No.2360-91/1983 filed by Retired Officers of the Board and pending in the Supreme Court and W.P.Nos.77074/93, 17126/93, 5221/93, 10199/92 pending in the High Court of A.P.
 - b) W.P.No.19836/2000, W.P.No.3470/2008 and 14264/2009 pending before the Hon'ble High Court of A.P, and

4. Sri D.Bhaskara Rao, Deputy Executive Engineer/Mechl working under the control of Chief Engineer/O&M/Dr.NTTPS on temporary promotion as Executive Engineer/Mechl, is posted at DCPH under the control of Chief Engineer/O&M/LSHES. He is directed to assume charge on promotion as Executive Engineer/Mechl at the place of posting ordered.

5. The Chief Engineer/O&M/Dr.NTTPS is requested to relieve Sri D.Bhaskara Rao, Deputy Executive Engineer/Mechl by making local arrangements so as to enable him to assume charge as Executive Engineer/Mechl at the place of posting ordered above. The alternative arrangements issued if any stands cancelled on assumption of charge by the promotee.

6. Sri D.Bhaskara Rao, Deputy Executive Engineer/Mechl is directed to assume charge as Executive Engineer/Mechl at the place of posting ordered. The promotee is allowed for a joining time of 15 (Fifteen) days to join the post from the date of receipt of the order of appointment sent to the candidate by register post with acknowledgement due or by any other means. If he fail to join or evade joining within stipulated period or proceed on leave from date of receipt of this order, his promotion rights shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1st cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

7. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble Supreme Court/ Hon'ble High Court against the Writ Petitions pending if any.
