**ORDER:**

4. Sri J. Venu Gopala Rao, Accounts Officer, working under the control of Chief General Manager (R&A) on temporary promotion as Senior Accounts Officer is transferred and posted as Senior Accounts Officer (B&R), O/o Chief General Manager (R&A).

5. The concerned Controlling Officer is requested to relieve Sri J. Venu Gopala Rao, Accounts Officer by making local arrangements so as to enable him to join at the place of posting ordered.

7. Sri J. Venu Gopala Rao, Accounts Officer is requested to assume charge on promotion as Senior Accounts Officer at the place of posting ordered after obtaining proper relief from the present post. No request for change of posting or sanction of leave will be entertained.
