ORDER :

In Pursuance to the Hon'ble High Court Orders W.P.No.6898/2019 and also CC.No.897/2021, the date of joining of Sri S. Nagendra, in the cadre of Jr. Personnel Officer was refixed w.e.f. 31.03.2010 and his seniority fixed below to Sri. P.Md. Sajid Ali Khan, the then JPO now PO and above Smt R. Bhavani Padmaja the then JPO now PO in the review DPC dt.11.11.2022.

2. Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part -II read with Regulation 8(2)(a) & (c) of APSEB SRs Part-II as adopted by APGENCO, the case of Sri. S. Nagendra, JPO was reviewed and notionally promoted as Personnel Officer with effect from 01.06.2019 i.e., the date of assumption of charge of his immediate junior i.e., Smt R. Bhavani Padmaja as Personnel Officer vide G.O.O. No.62/JS(Per)/2019, dt. 31.05.2019. However, the monitory benefit shall be paid from the date of actual assumption of charge as Personnel Officer on promotion.

3. The promotion ordered in para 2 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

4. The promotion ordered in para-1 above is subject to the result of S.L.P.Nos.2360-91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Honourable Supreme Court of India and W.P.No.1173/91 pending in the Honourable High Court of Andhra Pradesh.

5. Sri. S. Nagendra, Jr. Personnel Officer on promotion as Personnel Officer ordered in para 2 above is posted to the control of Chief General Manager (Adm, IS&ERP)/VS/VJA in one of the existing vacancy.

6. He is requested to assume charge as Personnel Officer as ordered in para 5 above, after obtaining proper relief from the present post of JPO. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No. 231/JS(P)/08, Dated 02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
