ORDER:

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, 04 (Four) No. Assistant Executive Engineers/Civil and 01 (One) No. Assistant Engineer/Civil mentioned in the annexure appended to this order are promoted temporarily to act as Deputy Executive Engineers/Civil with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto. The promotion is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized. Further, as per the memo 3rd cited, the promotion issued is subject to the outcome of the disciplinary case pending against the senior employee. If the senior officer/employee, on whom the disciplinary case pending, is completely exonerated/warned/censured in the disciplinary case, then he will be promoted duly reverting the junior most officer, if vacancies are not available.

3. The promotions ordered in para-1 above is liable to be reviewed based on the outcome of;

- a) W.P.No.2360-91/1983 filed by Retired Officers of the Board and pending in the Supreme Court and W.P.No.77074/93, 17126/93, 5221/93,10199/92 pending before the High Court of A.P., and
- b) W.P.No.19836/2000, W.P.No.3470/2008 and W.P.No.14264/2009 pending before the Hon'ble High Court of A.P.

4. 04 (Four) No. Assistant Executive Engineers/Civil and 01(One) No. Assistant Engineer/Civil on temporary promotion as Deputy Executive Engineers/Civil and 03(Three) No. Deputy Executive Engineers/Civil & 01 (One) No. Assistant Executive Engineer/Civil on transfer are posted to the places noted against their names in the Annexure appended to this order. The Promotees/Transferees are requested to assume charge/Join as Dy.EE(Civil)/AEE(Civil), at the place of posting ordered.

5. The concerned controlling officers are requested to relieve the promotees/ transferees by making local arrangements, so as to enable them to assume charge at the place of posting ordered in the Annexure appended to this order. The alternative arrangements issued if any stand cancelled on assumption of charge by the concerned promotees/transferees.

6. The promotees are requested to assume charge on promotion as Deputy Executive Engineers/Civil at the place of posting ordered. The promotees are allowed for a joining time of 15 (Fifteen) days to join the post from the date of receipt of the order of appointment sent to them by register post with acknowledgement due or by any other means. If they fail to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, their promotion rights shall be forfeited for the current panel year and the names of such candidates shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1st cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

7. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble High Court against the Writ Petitions pending if any.

8. Leave salary, pension and Gratuity contributions shall be remitted by the deputation stations as per the G.O.O.No.178/JS(Per)/09, Dt: 07.08.2009.
