**ORDER:**

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part –II, as adopted, Sri M. Ramesh Babu, Senior Accounts Officer is promoted temporarily to act as General Manager (Finance) with effect from the date of assumption of charge.

Ramesh Babu, Senior Accounts Officer, working under the control of Chief General Manager (Resources & Accounts) on temporary promotion as General Manager (Finance) ordered above, is posted as General Manager (Finance), O/o Chief General Manager (Resources & Accounts) duly terminating the additional charge arrangements made vide ref. 3<sup>rd</sup> cited.

5. The concerned controlling officer is requested to relieve Sri M. Ramesh Babu, Senior Accounts Officer by making local arrangements so as to enable him to join at the place of posting ordered.

Ramesh Babu, Senior Accounts Officer is requested to assume charge on promotion as General Manager (Finance) at the place of posting ordered after obtaining proper relief from the present post. also be initiated against him for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
