ORDER:

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part–II, as adopted, Sri Y. Prabhakar, Junior Accounts Officer is promoted temporarily to act as Assistant Accounts Officer with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

The promotion ordered in para-1 above is subject to the result of S.L.P.Nos.2360-91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Hon'ble Supreme Court of India and W.P.No.1173/91 pending in the Hon'ble High Court of Andhra Pradesh, and also subject to the outcome of W.P.No.39011/2017 and W.A.No.657/2024 pending in Hon'ble High Court of Andhra Pradesh.

4. Sri Y. Prabhakar, Junior Accounts Officer on temporary promotion as Assistant Accounts Officer ordered at para-1 above, is transferred and posted as Assistant Accounts Officer/Dr. M.V.R. RTPP vice Sri K. Prasad, Assistant Accounts Officer transferred.

5. On relief, Sri K. Prasad is posted as Assistant Accounts Officer, O/o Chief General Manager (R&A), Vidyut Soudha, Vijayawada. He is not entitled for TTA and Joining Time, as the transfer is ordered at his own request.
