ORDER:

Under Regulation 14 (a) (1) of A.P.S.E.B. SRs Part-II, as adopted, Sri M. Madhava Rao, Accounts Officer is promoted temporarily to act as Senior Accounts Officer with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

The promotion ordered in para-1 above is subject to the result of S.L.P.Nos.2360-91/83 filed by the Retired Officers of the erstwhile APSE Board and pending in the Hon'ble Supreme Court of India and W.P.No.1173/91 pending in the Hon'ble High Court of Andhra Pradesh, and also subject to the outcome of W.P.No.39011/2017 and W.A.No.657/2024 pending in Hon'ble High Court of Andhra Pradesh.

4. Sri M. Madhava Rao, Accounts Officer (Internal Audit Cell), working under the control of Chief General Manager (Audit & Trust), on temporary promotion as Senior Accounts Officer is transferred and posted as Senior Accounts Officer (Stores) vice Sri P.S.V.R. Nagabhushana Rao, SAO transferred. On relief, he is posted as Senior Accounts Officer (Pay & Accounts), under the control of Chief General Manager (R&A), duly terminating the Additional Charge arrangement made vide ref. 3rd cited.

5. The concerned controlling officers are requested to take necessary action by making local arrangement so as to enable them to join at the place of posting ordered.

6. Sri M. Madhava Rao, Accounts Officer is requested to assume charge on promotion as Senior Accounts Officer at the place of posting ordered after obtaining proper relief from the present post. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No.231/JS(Per)/2008, dt.02.08.2008. Necessary departmental disciplinary

action as deemed fit shall also be initiated against his for non-compliance of the orders issued above. No request for change of posting or sanction of leave will be entertained.
