**ORDER:**

Under Reg.14 (a) (1) of APSEB Service Regulations Part-II, as adopted, 02 (Two) No. Executive Engineers/Elecl as mentioned in the Annexure appended to this order are promoted to act temporarily as Superintending Engineers/Elecl with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto.
3. The promotion ordered in para-1 above is without prejudice to the seniority of the officers that will emerge after review of FCG list of Assistant Engineers of Electricity Department as on 01.11.1956 is finalized.
4. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of ;
  - a) W.P.No.2360-91/1983 filed by Retired Officers of the Board and pending in the Supreme Court and W.P.Nos.77074/93, 17126/93, 5221/93, 10199/92 pending in the High Court of A.P. and
  - b) W.P.No.19836/2000, W.P.No.3470/2008 and 14264/2009 pending before the Hon'ble High Court of A.P.
5. The 02 (Two) No. Executive Engineers/Elecl on temporary promotion as Superintending Engineers/Elecl are posted to the places noted against their names in the Annexure appended to this order, against the superannuation vacancies of Sri T.Ravi Kumar (Emp Id:1017150), SE/Elecl/ Dr.M.V.R.RTPP & Sri P.Rama Mohana Murthy (Emp Id:1016821), SE/Elecl/Dr.M.V.R.RTPP arising on 31.08.2024 A.N. The promotees are directed to assume charge as Superintending Engineers/Elecl, at the place of posting ordered.
6. The concerned controlling officers are requested to relieve the promotees by making local arrangements, so as to enable them to assume charge at the place of posting ordered in the Annexure appended to this order. The alternative arrangements issued if any stand cancelled on assumption of charge by the concerned promotee.

7. The promotees are directed to assume charge on promotion as Superintending Engineers/Elect at the place of posting ordered. The promotees are allowed for a joining time of 15 (Fifteen) days to join the post from the date of receipt of the order of appointment sent to the candidates by register post with acknowledgement due or by any other means. If they fail to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, their promotion rights shall be forfeited for the current panel year and the names of such candidates shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1<sup>st</sup> cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

8. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble Supreme Court/ Hon'ble High Court against the Writ Petitions pending if any.
