ORDER :

4. Sri S. Mahaboob Basha, Personnel Officer on promotion as Assistant Secretary ordered above, is transferred and posted as Assistant Secretary/O&M/ LSHES.

5. The concerned controlling officer is requested to take necessary action by making local arrangements so as to enable him to join at the place of posting ordered.

6. He is directed to assume charge on promotion as Assistant Secretary at the place of posting ordered. If he fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, his promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No.231/JS(Per.)/2008, dt.02.08.2008. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above.
