ORDER :-

4. They are requested to assume charge accordingly after obtaining proper relief from the present place of working.
5. The concerned Controlling Officers are requested to relieve the above Assistant Civil Surgeons within 15 days from the date of issue of this order. Otherwise, the promotee shall be treated as deemed to have been relieved of their duties after expiry of the stipulated period.
6. They are requested to assume charge on promotion as Deputy Civil Surgeons at their place of posting. If they fails to join or evade joining within the stipulated period or proceeded on leave from the date of receipt of this order, their promotion right shall be forfeited for the current panel and the name of the candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancies, in terms of orders issued in G.O.O.No:231/JS(P)/08, Dt:2.8.2008. Necessary departmental action as deemed fit shall also be initiated against them for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.
