**ORDER:**

Under Reg.14(a)(1) of APSEB Service Regulations Part-II, as adopted, 01 (One) No. Executive Engineer/Civil is promoted to act temporarily as Superintending Engineer/Civil with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and is liable to be terminated at any time without notice and without assigning any reasons thereto. Further, as per the memo 3<sup>rd</sup> cited, the promotion issued is subject to the outcome of the disciplinary case pending against the senior employee. If the senior officer/employee, on whom the disciplinary case pending, is completely exonerated/warned/censured in the disciplinary case, then he will be promoted duly reverting the junior most officer, if vacancies are not available.

3. The promotion ordered in para-1 above is liable to be reviewed based on the outcome of ;
- a) The Judgment to be delivered by the Hon'ble Supreme Court in the appeal filed against the judgment in W.P.No.4219/78 and W.P.Nos. 2360-91/1983.
  - b) The Judgment to be delivered in W.P.Nos.15565/1989, 3482/1990, 5135/1990, 9558/1991 and W.A.No:135/1996 pending before the Hon'ble High Court of A.P. and
  - c) The Judgment to be delivered in W.P.No.3470/2008 pending before the Hon'ble High Court of A.P.

4. The posting of 01 (One) No. Executive Engineer/Civil on temporary promotion as Superintending Engineer/Civil; 01 (One) No. Superintending Engineer/Civil on transfer and modified posting of 01 No. EE/Civil on promotion as SE/Civil are mentioned in the Annexure appended to this order. The promotee/Transferee are directed to assume charge as Superintending Engineer/Civil, at the place of posting ordered.

5. The concerned controlling officers are requested to relieve the promotee/transferee by making local arrangements, so as to enable them to assume charge at the place of posting ordered in the Annexure appended to this order. The alternative arrangements issued if any stand cancelled on assumption of charge by the concerned promotees/transferee.

6. Sri R.S.V.Krishna Mohan, Executive Engineer/Civil is directed to assume charge on promotion as Superintending Engineer/Civil at the place of posting ordered. The promotee is allowed for a joining time of 15 (Fifteen) days to join the post from the date of receipt of the order of appointment sent to him by register post with acknowledgement due or by any other means. If he fails to join or evade joining within stipulated period or proceed on leave from the date of receipt of this order, his promotion rights shall be forfeited for the current panel year and the name of such candidate shall be placed before the next DPC for consideration in the next panel year subject to availability of vacancy in terms of G.O.O. 1<sup>st</sup> cited. Necessary departmental disciplinary action as deemed fit shall also be initiated against him for non-compliance of orders issued above. No request for change of posting or sanction of leave will be entertained.

7. The orders are liable for revision without prior notice subject to outcome of orders of Hon'ble Supreme Court/ Hon'ble High Court against the Writ Petitions pending if any.

8. Leave Salary, Pension and Gratuity contributions shall be remitted by the deputation stations as per the G.O.O.No.178/JS (Per)/09, Dt: 07.08.2009.
