ORDER:

Under Regulation 14 (a) (1) of A.P.S.E.B SRs Part-II, as adopted, the following Five (05 Nos.) Assistant Accounts Officers are promoted temporarily to act as Accounts Officer with effect from the date of assumption of charge subject to the following conditions.

- b) They have to report at the place of posting as ordered within 15 days from the date of issue of orders, else the salary of the such employee shall be withheld by the respective drawing and disbursing officers with effect from the date of deemed relief.
- c) Necessary disciplinary action will be initiated in terms of Regulation 4 (xix) of APSEB Conduct Regulations against the candidates who attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of change of posting.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is subject to the result of S.L.P.Nos.2360-91/83 filed by the Retired Officers of the erstwhile APSEB and pending in the Hon'ble Supreme Court of India and W.P.No.1173/91 pending in the Hon'ble High Court of Andhra Pradesh, and also subject to the outcome of W.P.No..39011/2017 and W.A.No.657/2024 and if any WPs pending in Hon'ble Supreme Court/High Court of Andhra Pradesh.

4. The Five (05 Nos.) Assistant Accounts Officers on temporary promotion as Accounts Officers and transfer of one (01) number Accounts Officer posted to the places noted against their names in the Annexure appended to this order.

5. The Concerned Controlling Officers are requested to relieve the promotees/transferee so as to enable them to join at the place of posting.
