In the G.O.Rt.4th read above, the Law Department, Government of Andhra Pradesh have appointed Sri.Kilaru Krishna Bushan Chowdary, Advocate as Standing Counsel for the Andhra Pradesh Power Generation Corporation Limited (APGENCO) in the High Court of Andhra Pradesh for a period of 3 (three) years from the date of assumption of charge of the post or till termination of her services, whichever is earlier. It was also ordered therein that the conditions of service shall be in accordance with the instructions issued in the G.O. first cited read above as amended from time to time.

2. In the reference 5th cited, Sri.Kilaru Krishna Bushan Chowdary, Advocate has given his acceptance for appointment as Standing Counsel for APGENCO as per the orders issued by the Law Department vide G.O.Rt.No.241 Law (G) Department, dated 25.07.2025.

3. After careful consideration, the APGENCO hereby recorded the orders issued in G.O.Rt.No.241 Law (G) Department, dated 25.07.2025, 4th read above by appointing Sri.Kilaru Krishna Bushan Chowdary, Advocate as Standing Counsel to APGENCO for a period of 3 (three) years from the date of assumption of charge.

4. Consequent upon his appointment as Standing Counsel to APGENCO, Sri.Kilaru Krishna Bushan Chowdary, Advocate, is required to appear on behalf of APGENCO in the Hon'ble High Court in connection with: -

- All Writ Petitions and Writ Appeals on all matters relating to APGENCO arising in the Hon'ble High Court of AP.
- All second appeals in High Court as entrusted by APGENCO.

- All Civil Miscellaneous Appeal (CMAs) and Civil Revision Petitions(CRPS) in High Court.
- Required to appear before "Arbitrator/s" and "Authority/ies" under various enactments whenever requested by the APGENCO.
- Required to tender advice on matters referred to him by various Officers of the APGENCO for Legal opinion.
- Required to inform daily about the new cases filed against the APGENCO, the cases heard and disposed of during the day, where Judgments were delivered, the details of judgments along with opinion whether are any grounds to file an appeal or not and any other important information to be conveyed to APGENCO, so as to ensure follow up action promptly.

5. The APGENCO reserves its right to appoint any other Sr.Advocate/Advocates in any specific case/s either before the Hon'ble High Court A.P. or any other Court or Tribunal or Forum depending on the nature and stakes involved in a case and the specialization possessed by such Advocate in the subject relating to such case/s.

6. As per the orders vide G.O.RT.No.241 Dt.25.07.2025 and in accordance to G.O.O.2nd cited, Sri.Kilaru Krishna Bushan Chowdary, Standing Counsel for APGENCO is entitled for payment of Monthly Honorarium of Rs. 50,000/- (Rupees Fifty Thousand Only) with effect from 28-07-2025(i.e. the date of assumption of charge as Standing Counsel) in addition to Payment of "Case wise Fee" and "Expenses" for professional services rendered by him on behalf of APGENCO as per the orders issued by APGENCO vide reference 3rd cited.
