4. They are also requested to submit the terminal benefits proposals in prescribed proforma along with required undertakings to the controlling officer concerned before 6 months duly enclosing a copy of the said notice without fail.

5. The concerned controlling officers are directed to relieve the above individuals positively on the date of their retirement duly making necessary local arrangements. Further, they are directed to service the notice to the concerned and obtain the date acknowledgement in token of having received the retirement notice and furnish the same to this office immediately.
